Example 1 (Policy Effective on/after 07/21/2011)

Example Other States/Exempt Premium Form

When reporting a multi-state policy and manually filing, you must also complete the new Other States / Exempt Premium Form.

Using the example for a policy effective **07/22/11 – 07/22/12**: Texas is the Home State with premium of: Texas \$10,000., Louisiana \$2,500., Oklahoma \$1,000.

- In the **Total Premium** box, show **\$13,500.00** - the full policy premium (incl. policy fee(s))
- In the **Texas Premium** box, show **\$13,500.00** because Texas is the home state and all premium reported and taxed as Texas premium (post NRRA)
- In the **Other States (post NRRA)** box, show **\$3,500.00** which is the total of the non-Texas premium (for Louisiana and Oklahoma).
- In the **Individual States** boxes, show the premium for each individual *state code*. In this example: **LA** (for Louisiana) as \$2,500.00, and **OK** (for Oklahoma) as \$1,000.00.
