Export Basic

Step 1: Click Export Basic on the Search Results page to export <u>basic</u> data elements for all records matching the search criteria: Policy Number, Insured Name, Transaction Type, Total Premium, Tax, Stamping Fee, Total Gross, Effective Date, Report Date, Batch No., Broker Name, and TDI License No.

Step 2: Exported file will be displayed at the bottom of your browser window. To open document, double click on the CSV file.

Export Full

After completing STEP 1 from Policy Search section

Step 1: Click Export Full on the Search Results page to export all data points included and/or required to make a filing submission with SLTX. This also includes any data captured by SLTX or later records for the filed record. This involves, but is not limited to all data contained in the <u>basic export</u>, and: SLTX ID (Policy ID), Corrects Original ID, Issue Date, Filing User, Entry Method, Last Updated Date, Insurer, Coverage Code, Coverage Amount, Class Code, Policy Limit, and Reference / Custom ID.

Step 2: Exported file will be displayed at the bottom of your browser window. To open document, double click on the CSV file.

Special Note for Records with multiple coverage codes and/or insurers:

When a single record with more than one coverage and/or more than one insurer, data will be reflected as multiple rows in the export to demonstrate appropriate coverage and insurer amounts. However, the "Total Premium" in column G will not be separated. In this instance, you must calculate premium amounts from the "Coverage Amount" in column AQ.

You may easily identify this data scenario by observing the SLTX ID column – SLTX ID will be displayed more than once (one row for each coverage / insurer combination). Otherwise, there will be a single row per SLTX ID.
