Example 2 (Policy Effective before 07/21/2011)

Example Other States/Exempt Premium Form

When reporting a multi-state policy and manually filing, you must also complete the new Other States / Exempt Premium Form.

Using the example for a policy effective **07/22/10 – 07/22/11**:

This is a multi state policy with premium of: Texas \$10,000., Louisiana \$2,500., Oklahoma \$1,000.

- In the **Total Premium** box, show **\$13,500.00** the full policy premium (incl. policy fee(s))
- In the Texas Premium box, show \$10,00.00 because only Texas premium is taxable prior to 07/21/2011 (pre-NRRA)
- In the **Other States (post NRRA)** box, show **\$3,500.00** which is the total of the non-Texas premium (for Louisiana and Oklahoma).
